

#### Conditions of Plant Hire

- (1) All plant and equipment will be supplied in good condition ready for use, all break downs must be reported so that we can carry out repairs. You are not permitted to carry out repairs except for punctures, any repairs due to your negligence will be charged to you.
- (2) You (the hirer) are responsible for all damage (except for wear and tear), where an operator is provided you (the hirer) he/she works under your direction, Hickman Brothers Landscapes Ltd are not liable for any damage caused.
- (3) You (the hirer) are responsible for the full replacement costs due to loss and you are advised to take out insurance to cover this, the period of responsibility is from collection to return.
- (4) No charge will be made to cover periods of break down unless due to your negligence.
- (5) Plant and Equipment will be supplied fuelled and ready for use, subsequent re-fuelling at your cost, plant to be returned fully fuelled or a charge will be made for fuel used.
- (6) Wear and tear to points, blades etc. will be chargeable to the hirer.
- (7) We cannot guarantee to replace equipment due to break downs, and we will not accept liability for any consequential damage or costs that may arise due to a break down.
- (8) You (the hirer) will allow reasonable access for servicing plant and equipment.
- (9) Plant will be delivered to a hard area and collected from a hard area, it is your responsibility to ensure that machinery is not bogged down on soft ground or alike.
- (10) Value Added Tax will be added at the current rate to all charges.
- (11) Consumable items are supplied on a sale or return basis with hired plant.
- (12) A cleaning charge will be levied for any equipment returned in a dirty condition.
- (13) It is your (the hirers) responsibility to use the equipment safely, any risk assessment is to be carried out by the hirer.  
You are advised that machinery can be dangerous if used incorrectly, it is important that the hirer reads and follows all instructions carefully and comply with all requirements regarding its safe use. Protective clothing must be worn when necessary and particular attention should be given to the protection of head, eyes, lungs, hands and feet. With regard to electrical equipment we recommend the use of a circuit breaker all 240v equipment.

#### Conditions of Skip Hire

- (1) We will not accept the following:  
Asbestos, Tyres, Liquids, TV's, Monitors, Fire Extinguishers, Batteries, Fridges, Freezers, Food, Gas Bottles, Florescent Lights, Contaminated or Hazardous Material of any Description. Plasterboard can not be placed in mixed skips.
- (2) You (the hirer) is solely responsible to ensure none of the above is placed in containers or skips.
- (3) If you (the hirer) direct the lorry of the public highway it becomes solely your responsibility and risk regarding any damage and or recover of costs.
- (4) An extra charge for delivery will be added outside of a 15 mile radius of Burford.
